The Dzongkhag COVID-19 Task Force meeting held on 5.1.2021 deliberated following issues to be implemented with effect from 6.1.2020.

Phase I- Unlocking Strategies for Tsirang Dzongkhag (6.1.2021 to 12.1.2021)
