

**Resolution of 30<sup>th</sup> COVID-19 Task Force Meeting  
National Lockdown- Phase 2 (w.e.f 23/12/2020)**

Taskforce deliberated and resolved following issues;

On 5.1.2021, Dzongkhag Taskforce deliberated and drew 1<sup>st</sup> Phase of Unlocking Strategies and at around 3.30 PM, Public notification regarding Unlocking from 6.1.2021 was served accordingly. However, Public Notification served earlier on the day had to be cancelled owing to latest directives from NC19TF. Later at around 11.40 PM on 5.1.2021, edited version of Public notification and Unlocking Proposal was submitted to SC19TF.


Issued Deliberated and resolved as follow;

1. Since security point at Wakleytor and Daraytso are strongly instituted, commuters might take advantage to skip COVID test and travel via lateral traditional routes. Taskforce decided to Strengthening of security personnel at the lateral routs. Accordingly, Gewog Administration to strictly monitor the lateral route besides such routes are daily patrolled by RBP and Desuups. Tsokpas to report defaulters as soon as possible to RBP. Occurrence of any lapses from the Gewog Administration be dealt as per the COVID-19 Protocols.
2. As usual Taskforce members to break up into groups and monitor the situation in and around the dzongkhag. Members are mandated to impart awareness, do's and don'ts during the first phase of unlocking. Further directed to observe COVID-19 health Protocol that are in placed.
3. Since, contained construction activities are allowed for a week, Engineering Sector to monitor the work site. Concern site engineers to keep detail record of inflow and outflow of Labourer with COVID test documents and report to surveillance team leader ADHO for their health check.
4. Rilangthang and Daraytso shops to remain closed as per the notification on unlocking.
5. Upon receipt of several call from Mr. Tashi Gyelthen in consigning the egg load to Bumthang, the 30<sup>th</sup> Dzongkhag COVID-19 Task Force meeting held on 6.1.2021 decided to permit one-way movement only (Tsirang-Bumthang) after fulfilling health protocols prior to travel. DLO to serve written letter reminding him to get prior vehicle registration with Taskforce for ferrying any consignments during such critical period. Further, Mr. Tashi Gyeltshen to be reminded that breaching of any COVID norms be seriously dealt as per COVID-19 protocol and law of the Land.
