

**Resolution of 18<sup>th</sup> COVID-19 Task Force Meeting  
National Lockdown- Phase 2 (w.e.f 23/12/2020)**

Venue: Municipal Hall  
Date: 22/12/2020, Time: 8:30 Pm  
Members: Taskforce Members

Tsirang Incident Commander Dzongdag conveyed His Majesty's Key Messages on second Phase of Lock down received via Gyalpoi Zimpon that "Civil Servant to be alert and perform with best of the ability at this hour of need".

Towards ensuring SMART lockdown, Taskforce deliberated and resolved following issues for implementation w.e.f 23.12.2020.

1. Task Force members deliberated on business operation by the identified essential service providers/shops under three Zones. It was resolved that three zones under Damphu town to operate their business as scheduled:
2. Task Force members deliberated that essential Service Providers (Groceries, Vegetables, Meat Shop, FCB and Medical to operate their business while rest business entities to remain closed for a period of a week. The essential service provider are identified based on the guide lines from NTF
  - A. Identified Groceries, essential service provider under Zone 2. Damphu Core area are;
    1. Kuenphen Tshongkhang
    2. Namsey Tsongkhang
    3. Sikam Tsongkhang
    4. Uma Tsongkhang
    5. Terwa Tsongkhang
  - B. All Groceries Shops (four Shops) under Zone 1 (Damphu Central School area) to be kept open.
  - C. Identified Groceries, essential service provider under Zone 3 Dratsang area are Kamala, Pardhan and Shop above BPC Junction at Darjay and Kamala Shop near RAA to be allowed to operate their business.
3. 12 Gewogs under Tsirang Dzongkhag to be kept under lockdown for a period of one week (23.12.2020 to 29.12.2020) and Card System will be implemented on a need basis.
4. Construction activities to be continues at the respective construction Sites.
5. Shop below Ex. Drungpa at Relangthang area to operate, and rest including all business entities at Burichu Serutar to remain closed.

6. Indra Shop at Goserling Gewog, animal Feed Supplier shop near RDP workshop and Ashi Building to operate during this lock down period.
7. Livestock and Agriculture produce to operate on card system as usual.
8. Security Operation Centre is identified in Moenlamthang and service provider will be stationed at their respective home.
9. Waste management and Municipal services to be operated as usual 4 Movement Cards to be issued permanently for entire lock down period. In case of misuse of the movement cards by municipal staffs to be dealt by RBP.
10. Task Force Members decided to implement Restrictive Movement w.e.f 23.12.2020 at 9 AM. Residents to avail services based on card issued during first lock down. Shop keepers to do stock clearings before 9 AM.

11. Other essential to be distributed by the task force based on need basis.
12. Task Force decided Security Personnel will be stationed at Moenlamthang whereas Deesuups to make movements from their respective homes. Lunch break will be given to move to respective homes.
13. Task Force decided that Facilitation of services to discharge Patients to avail movement pass upon declaration of discharge Certificate. Those on emergencies to be allowed without any hindrances from security's end. Respective BHUs to certify on the deployment of Ambulances for pickup for emergencies.
14. Task Force resolved that Gewog Boleros to serve as Backup for any emergencies. Taxis to be used in local areas, and Private Vehicles (volunteers) to be used on need basis. Logistic Team to be contacted in need of any Vehicles. Any deployment of Vehicles to be routed through logistic Chief Dzongrab.
15. Task Force decided that Medical Staffs on duty to use their own Vehicles for their own transportation. Movement Cards to be issued to staffs on duty and advent of misuse of the card by the medical staffs to be dealt by RBP.
16. Task force resolved that Hospital Staffs residing in RBP colony to arrange their own accommodation (non-returnable to RBP) till the lock down period.

17. Taskforce decided that Vehicle and Staff Movement Cards for other Essential Service Provider ( Bhutan Telecom, Bhutan Power Corporation, Cable, Tashi-cell) to be issued case by case.
18. The Task Force decided that Thromdae Thuemi and town representative to ensure that Druk Trace App is installed and functional in all business entities.
19. Task Force decided that Municipal Tanker to be deputed for hand washing water filling and watering of flowers in and around Damphu town.
20. All shops to shut down by 8 PM.
